

You wish to participate in a Dog Training Event and You hereby voluntarily assume (insofar as the law permits) the risks of any bodily injury (including death) to Yourself and/or to anyone that accompanies You to a Dog Training Event and/or to Your dog or to the dog of another.

You hereby release Me from all Claims and do hereby indemnify Me and will keep Me indemnified and hold Me harmless from and against all Claims.

You agree to comply with all instructions given to You by Me relating to Your participation in a Dog Training Event. You agree to release Me from all Claims arising out of Your refusal, neglect, default or omission to comply with such instructions and do hereby indemnify Me and will keep Me indemnified and hold Me harmless from and against all such Claims arising out of Your refusal, neglect, default or omission to comply with such instructions.

You agree that these waivers are ongoing and will apply to all future Dog Training Events at any venue nominated by Me in which You participate.

You acknowledge that this document is contractual and binding on You and may be relied upon by Me with respect to any Claims by You, Your heirs, successors, trustees, executors and assigns, and the above waivers, releases and indemnities are given in consideration of Me permitting You to participate in a Dog Training Event at a venue nominated by Me.

You warrant that You do not suffer from any medical condition that may affect Your ability to participate safely in a Dog Training Event.

Due to Your agreements, releases, waivers and indemnities You acknowledge and agree that I NEED NOT INSURE YOU for any bodily injury (including death) to You or damage or loss of property (including a dog) regarding Your participation in a Dog Training Event but that YOU WILL EFFECT YOUR OWN INSURANCE for such risks.

You agree that I may use any photographs or film or video taken at any Dog Training Event containing Your image and/or the dog You are training in promotional material and You waive any claim I may otherwise have in respect of that use (including but not limited to copyright).

You agree that I may send You future course / seminar / workshop information or advertising material to the address You have supplied including to the email address that You have provided to Me.

## For the purposes of this Agreement: - unless repugnant to the context of this Agreement;-

A reference to õthis Agreementö means this Agreement set out in this document which includes the other side of this document.

A reference to õYouö extends to and includes any other person (including children) that accompanies You to a Dog Training Event as well as to any dog You bring to that Dog Training Event.

A reference to õMeö extends to and includes Me, My officers, committee members, My employees, agents, contractors, volunteers and the owner of the premises (venue) at which a Dog Training Event is held.

A reference to a õDog Training Eventö means a dog training event organized by Me at a venue nominated by Me. A reference to a õClaimö includes any claim, action, suit or proceedings for compensation or otherwise (including but not limited to damages, losses and legal costs) arising out of any bodily injury (including death) to You or damage or loss of property (including a dog) with respect to Your participation in a Dog Training Event.

A reference to the singular includes a reference to the plural and vice versa.

Any provision in this Agreement that is found to be void or unenforceable such be stricken from this Agreement and the balance of this Agreement shall remain binding and this Agreement shall be construed and interpreted in My favour.
